President Ronald Reagan instituted Sanctity of Human Life Sunday (40th Anniversary, closest Sunday to March 22nd), ten years after the Roe v Wade court decision in 1973 to federally fund and mandate abortion in every state. Since 1973 there have been 63 million abortions in the United States. Since Roe v Wade was overturned in June 24, of 2023 it has been reported that several Planned Parenthood facilities have been closed, as many of the states are pro-life. How ever the abortion pill (mifepristone/RU-486) has been widely used and available in schools under the guise of 'Family Planning Clinic'. We are very saddened about this, but the good news is the 'Abortion Pill Reversal'. Colorado is the first state in the U. S. to ban use of the treatment and furthering enshrining abortion access in Colorado.
